Submission of returns

As an approved Registered Dealer in Controlled Oil you are required to submit a completed and signed HO5 return to the Mineral Oils Relief Centre (address shown on previous page) by the 21st day of the month following the end of the return period.

Your first return period will cover the period 30/09/2015 to 30/09/2015 and will be calendar monthly thereafter.

As you supply marked gas oil for use in private pleasure craft you are required to submit a completed and signed HO107 payment return (to the address specified on the return) and pay the duty due by 21st day of the month following the end of the return period or by the last business day before the 21st if this falls on a weekend or a bank holiday. Your payment return period will cover the period 30/09/2015 to 30/11/2015 and will be quarterly thereafter.

It is your responsibility to check that your customers are properly entitled to receive the oil in accordance with Notice 192 and/or Notice179A.
